These “procedures cannot duplicate or contradict Toastmasters International governing documents and policies, nor may they be more restrictive than Toastmasters International governing documents and policies.”¹ They may be changed by either the District Executive Committee or the District Council.

SECTION 1: OFFICERS

1.1 APPOINTED OFFICERS

As allowed by TI Policy, the appointed officers of this District shall be:

- Public Relations Officer
- District Secretary
- District Treasurer
- Area Governor for each Area.

SECTION 2: CONTESTS

2.1 DISTRICT SPEECH CONTESTS

The District shall hold two speech contests at the Fall Conference and two at the Spring Conferences as follows:

- Fall Conference:
 - Humorous Speech Contest
 - Evaluation Contest
- Spring Conference:
 - International Speech Contest
 - Table Topics Contest

2.2 DIVISION CONTESTS

Each Division shall conduct four (4) speech contests to provide a single contestant to the District Conferences as follows:

- Fall:
 - Humorous Speech Contest
 - Evaluation Contest
- Spring:
 - International Speech Contest
 - Table Topics Contest

If a Division has four or fewer areas, the District will allow the Areas to send two contestants to the division contest.

2.3 AREA CONTESTS

Each Area shall conduct four (4) speech contests to provide a contestant to the Division Contests as follows:

- Fall:
 - Humorous Speech Contest
 - Evaluation Contest
- Spring:
 - International Speech Contest
 - Table Topics Contest

If an Area has four or fewer clubs, the District will allow the clubs to send two contestants to the area contest.

2.4 CONTEST TROPHIES

Contest trophy recommended sizes for all contests are as follows:

- Club Trophies - maximum of 10"
- Area Trophies - maximum of 12"
- Division Trophies - maximum of 15"
- District Trophies - maximum of 17"
